

## Bibliotheca Giveaway June 2021 ALA Conference

### Terms and Conditions

Entrants will be deemed to have accepted these terms and conditions, and agreed to be bound by them, when entering this Promotion.

#### Eligibility:

1. This free prize draw ("Promotion") is open to Public Libraries in attendance at the ALA 2021 Conference.
2. Bibliotheca's employees and their families, employees of companies associated with the Promotion and all affiliates of such companies may not enter this Promotion.

3. To take part in this Promotion, entrants must, visit Bibliotheca's virtual booth and complete a form with their details
4. Maximum of one entry 1 per person.

PRIZE C **uniFi activ** includes: 1 uniFi activ controller to interact with screen\*, 1 year's software license for additional 4-screens (uniFi display, uniFi activ, selfCheck, remoteLocker), 1 year Wayfinding license, installation and set-up and 1 year maintenance and support. \*The library needs to provide the interactive screen.
9. To be eligible to claim the prize, winners must respond to the prize notification message within 7 days. Failure to respond within the requested period or provide their personal details will result in the prize being forfeited by the prize winner. Bibliotheca reserves the right to award the prize to an alternative winner.
